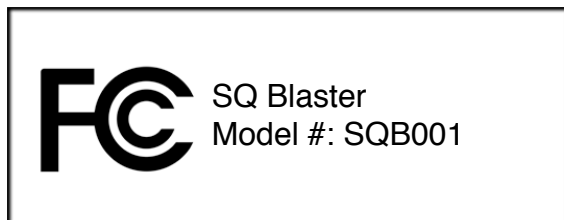


DECLARATION OF CONFORMITY WITH FCC RULES FOR ELECTROMAGNETIC COMPATIBILITY

We, Square Connect, Inc., located at 5960 Stoneridge Drive, Pleasanton, CA 94588, declare under our sole responsibility that the device, SQ Blaster, part #: SBQ001 complies with Part 15 of the FCC Rules.



Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation. Caution: Exposure to Radio Frequency Radiation

The device shall be used in such a manner that the potential for human contact normal operation is minimized. This equipment complies with FCC radiation exposure limits set forth for an uncontrolled environment. This equipment should be installed and operated with a minimum distance of 20cm between the radiator and your body.

Federal Communications Commission Notice

What is not covered by this warranty?

All above warranties are null and void if the Square Connect product is not provided to Square Connect for inspection upon Square Connect's request at the sole expense of the purchaser, or if Square Connect determines that the Square Connect product has been improperly installed, altered in any way, or tampered with. How to obtain warranty service.

- c. When you purchased the product.
- d. Copy of original receipt.

2. Square Connect's Customer Service will then instruct you on how to forward your receipt and Square Connect product and how to proceed with your claim.

Square Connect reserves the right to review the damaged Square Connect product. All costs of shipping the Square Connect product to Square Connect for inspection shall be borne solely by the purchaser. If Square Connect determines, in its sole discretion, that it is impractical to ship the damaged equipment to Square Connect, Square Connect may designate, in its sole discretion, an equipment repair facility to inspect and estimate the cost to repair such equipment. The cost, if any, of shipping the equipment to and from such

repair facility and of such estimate shall be borne solely by the purchaser. Damaged equipment must remain available for inspection until the claim is finalized. Whenever claims are settled, Square Connect reserves the right to be subrogated under any existing insurance policies the purchaser may have.
